**AVI VEHICLE CATEGORIES AND FEES  
(EFFECTIVE SEPTEMBER 9, 2008)**

**TERMINAL 1**

**Category 1:** 1-8 people, including the driver  
 0-45 minutes \$1.80  
 Each additional 15 minute increment +2.50  
 Total shall not exceed \$50.00 per trip fee for the same 24 hour period.

**Category 2:** 9-15 people, including the driver  
 0-45 minutes \$3.00  
 Each additional 15 minute increment +2.50  
 Total shall not exceed \$50.00 per trip fee for the same 24 hour period.

**Category 3:** 16-30 people, including the driver  
 0-60 minutes \$4.50 ←  
 Each additional 15 minute increment +5.00  
 Total shall not exceed \$50.00 per trip fee for the same 24 hour period.

**Category 4:** 31 or more people, including the driver  
 0-60 minutes \$15.00 ←  
 Each additional 15 minute increment + 5.00  
 Total shall not exceed \$50.00 per trip fee for the same 24 hour period.

**Category 5:** Service/Delivery  
 Continue with the decal program.  
 \$50.00 Administrative fee per vehicle per 6 months.

**Category 6:** All Rent-A-Car (RAC)

No AVI charges at this time, Director may impose AVI charges in the future at his discretion pursuant to applicable County Ordinance.

**Category 7:** Taxicabs  
 Per trip fee \$1.80

**Category 8:** Infrequent Users operating no more than once every six months  
 0-60 minutes \$50.00 User Fee

- 1) NO AVI CHARGE AT TERMINAL ONE DEPARTURES CURB
- 2) REGIONAL CARRIER WILL NOT BE CHARGED ADDITIONAL TRIP FEES IF THEY RETURN WITHIN 2 HOURS.
